The member hereby agrees not to disclose, transfer, reproduce or retain in any form or manner whatsoever all or any portion of the said list, nor permit any third party, agent, employee or contractor or its respective agents and employees to do so.

Electronic Format: The Chamber agrees to provide member with the use of its mailing list for one year. Quarterly updates will be provided. The member hereby agrees not to disclose, transfer, reproduce or retain in any form or manner whatsoever all or any portion of the said list, nor permit any third party, agent, employee or contractor or its respective agents and employees to do so.

\*An additional year of quarterly updated may be purchased at the discounted rate of \$350. This offer MUST be purchased by the end of the initial one-year electronic list lease.

For All Formats: The Member understands the list is proprietary to the Chamber.
